## Kasai - Kitchanga massacre: the list of suspects established by the military court of Goma

## Summary of the case

In February 2013, at least 206 people were killed in Kitchanga in what was presented as mere clashes against armed groups. For the Congolese military justice, 14 officers and non-commissioned officers bear responsibility for these deaths.

This list of suspects was established after 465 people were interviewed.

The 812<sup>th</sup> Regiment had been officially based in Kananga since February 2013. It was transferred after the massacre.

The Congolese military court first interrogated these suspects in Kananga in 2013.

In the first quarter of 2016, when the Congolese military court inquired about the location of its fourteen suspects, the military officials replied that they were assigned to Katanga and Equateur Province. On the basis of information received by the FARDC staff, the military court drew up a chart entitled "Annex 1, list of the accused to be returned to Goma". This chart served as a basis for the list of suspects presented below.

None of these soldiers has been charged despite the accusations against them.

At least four of the suspected officers were in Kananga.

Other members of the 812<sup>th</sup> Regiment, such as Lieutenant-Colonel Jules Butoni Bihama, were in Kananga between August 2016 and May 2017. They have all been redeployed out of Kananga and Tshimbulu, since March 2016.
